

Pioneer Behavioral Health to Present at 31st Annual Deutsche Bank Health Care Conference in Boston on May 2, 2006

(OTC Bulletin Board: PIHC) today announced that Bruce Shear, CEO of Pioneer Behavioral Health, will present at the 31st Annual Deutsche Bank Health Care Conference at 7:30 a.m. (Eastern) on May 2, 2006. The Conference will be held at the Sheraton Boston Hotel in Boston, Massachusetts.
